We will continue to work with all layouts to accommodate space requests, as you have probably noticed we are at max capacity in the buildings we currently have access to at the fairgrounds. The EGSF has resumed planning on second large commercial building adjacent to the Event Center, but it is still a long term planning project. In the meantime, we may have to ask one larger layout to "opt out" each year on a rotating basis until we have more space available. We will also be rotating the placement of the layouts to add variety of visual interest for our patrons. We value your attendance at the show, and will always do our best to incorporate as many layouts as possible each year!

Please note we are asking for all layout registrations to be submitted by January 20th 2025. After January 25th we will have a preliminary floor plan and will address any changes, special needs or requests. Please be sure that your club contact information is up to date. Jamey also utilizes the Puyallup show in January to address any concerns or questions face-to-face with the layout coordinators present.

- Layout Setup is scheduled to begin on Friday 21-Feb starting at 10:00am. General Setup for the show will be from 11:00am to 7:00pm & Saturday from 6:30am to 9:30am. PLEASE BE SETUP AND READY TO RUN BEFORE SHOW OPENS TO THE PUBLIC AT 10:00 AM.
- RV's spaces may be rented from the Fairgrounds. See their website for current reservation and cost information.
- There will be designated (free) parking spaces for trailers that may be left for the duration of the show.

3. The layout cannot extend into designated aisle spaces in accordance with fire access safety rules.
4. Electrical wiring shall meet all applicable electrical standards.
5. LOCOMOTIVES THAT GENERATE SMOKE OR ODORS ARE NOT ALLOWED.
